As this is your second block placement, your performance focus will be on general radiography examinations of non-complex patients with the goal of attaining advanced beginner level of skill. You will undergo performance assessments on radiography of a range of body regions. You will also be assessed on your professional behaviours and attributes. Reflective practice will assist you in developing your skills throughout this unit.
