Overview

Fraud is a major problem, estimated to cost Australia over \$3 billion each year. The incidence of fraud and corporate failure is increasing along with its cost. This unit is designed to provide you with an understanding of the risks of fraud or corporate failure occurring and an appreciation for the subsequent forensic review and processes. You will learn appropriate preventive and detective methods, examine the wide range of fraud threats to individuals and organisations, and appreciate the relevant legal resolution processes.

2 PRACTICAL ASSESSMENT

Practical Assessment

Task Description

This assessment has 2 parts - Part A Report (10%) and Part B In-Class Test (20%).

Part A Report (10%) This is a group assessment – 1-2 students per group. The group submits a written report on a chosen topic. Each student in the group will receive the same mark for the report. Word length for the report – 1500 words. You should refer to at least 5 sources in preparing your report using APA referencing. Topics and rubric will be available on Moodle. Submit your report via Moodle by the due date.

Part B Take-Home Test (20%) This is a 1-hour take-home test to be held at a scheduled time in Week 9. Two case studies with short-answer questions will be based on material covered in Weeks 1-5. Students may refer to lecture notes and the eBook, but not other Internet resources.
