Overview

In this unit, you will learn about the history of the building and construction industry, the importance of preparing accurate cost estimates, the basic cost components integral to building projects and the development of cost estimates for projects at different stages of their life cycle including feasibility studies, procurement, retrofitting and "change of use". You will have the opportunity to prepare partial cost estimates for competitive tenders, use tendering strategies, discuss successful and unsuccessful tenders, and capture tendering data into cost monitoring systems. Students who have successfully completed BLCN14040 should not enrol in this unit.
