Term Specific Information

This unit provides you the opportunity to complete 6 weeks of work placement with a placement provider in Clinical Measurement Science or Medical Laboratory Science. Each student will complete their placement as per the schedule organised with the Work Integrated Learning officers of the School of Health, Medical and Applied Science. Since this unit is entirely based on work placement, there are no lectures or tutorials.

Absenteeism: Work placement is an integral part of the CG93 course. If you are unable to attend your scheduled six week placement for any reason, please advise the Work Integrated Learning officers of the School of Health, Medical and Applied Science as soon as possible before the start of the scheduled placement.

Sick certificates: In case you are unable to attend some part of your placement due to sickness, please submit a medical or health related certificate to the unit coordinator. Medical or health-related certificates must be in the approved formats articulated in the CQUniversity Assessment Policy and Procedure (HE Coursework).

In the event that your condition could harm or negatively impact either yourself or those around you (e.g. put you at risk of exacerbating an injury, or pass on viral or bacterial infections to other students and staff), you will be sent home and will need to provide acceptable medical documentation for your absence, as stated above. Students who are sick and/or injured and cannot attend more than 3 days of work placement must submit a medical certificate to the unit coordinator and notify their work placement supervisor. In such event, alternative arrangements to complete the remaining hours of work placement will be made after consultation with the placement provider, and the unit coordinator.

Portfolio

Task Description

To provide structure to the learning, a placement workbook will act as the principle learning activity and assessment tool. For students of the Clinical Measurements major: the workbook has been developed in collaboration with placement providers and employers. For students of the Pathology major: the workbook has been developed in collaboration with placement providers and employers and aligns with Standards of Competence issued by the Australian Institute of Medical Scientists (AIMS). The workbook should be supported by a portfolio of additional evidence that you would like to include to demonstrate your knowledge, understanding and application during the placement. Such a portfolio is useful to show potential employers at interviews and demonstrates your achievements.

Training will be supervised by a qualified Medical Scientist, but at times training may be delegated to other competent staff. A series of activities have been designed to test your ability to contextualise the training. At the end of periods of training, in particular tasks the training supervisor will assess competence and sign a declaration that you have demonstrated a basic level of competence to perform the defined task. To develop communication skills you will be encouraged to ask questions of other members of the team in order to answer some of the tasks in the workbook. Some tasks can be marked against the standard CQUniversity grading criteria and will be used to determine an overall mark for the unit, whilst the competence-based tasks will be evaluated on a simple pass/fail basis. You must pass all competence-based tasks for which you have received training in order that the scored tasks can be used to determine

the overall grade for the unit.

You must pass all competence statements for which you have received training and achieve a minimum of 50% of the marks available.

Assessment Criteria

The workbook provides a breakdown of marks associated for each task and also provides guidance on what the marker is expecting you to include or consider. A minimum overall mark of 50% must be achieved for the marked assessment to pass the unit.

You must pass all competence-based tasks for which you have received training in order that the scored tasks can be used to determine the overall grade for the unit. Competence based tasks are outlined within your workbook.

Professional Practice Placement

Task Description

Clinical Placement occurs in the professional workplace. As a student you are provided access to that workplace on the condition that you demonstrate behaviours and attributes of a healthcare professional and present a positive image to the placement facility's staff and patients. Professional attributes such as good team work, communication, patient care and safe practice are highly valued by employers. In this placement, you will demonstrate your skills in this area.

It is your responsibility to ensure you have provided documentary evidence where applicable(to be forwarded to smas-clinicalplacements@cqu.edu.au) of the following BEFORE your placement commences:

- Australian Blue Card
- First Aid Certificate
- Hepatitis B vaccination
- Tuberculosis vaccination

PRIOR to commencement of your placement you will be required to complete a pre-placement checklist which is available on the Sonia site. The completed checklist must be submitted to the Sonia site.

Further information on the pre-placement requirements is available on the Sonia site.

Your placement supervisor will be requested to complete, sign, and return a report to the Clinical Placements Coordinator of the School of Health, Medical and Applied Sciences regarding your placement. Reports will be submitted on completion of 3 and 6 weeks of placement. These evaluations should be discussed with you prior to submission.
