General Information

Overview

On completion of this unit, students should be able to relate neurophysiology and pathophysiology to advanced clinical tests of neurological function including electroencephalography (EEG), nerve conduction studies (NCS) and evoked potential measurements. Therapeutic interventions for epilepsy and nerve entrapment will be discussed. Students will review all aspects of patient interaction including patient safety, legal and ethical issues and communication.

Task Description

As a clinical measurement scientist you will be responsible for conducting various clinical neurophysiological investigations and interpreting the results. You will be presented with a clinical case scenario of a patient with a neurological condition and will be required to answer a series of questions related to the clinical case. This assessment is designed to assess your understanding of EEG, interpretation of data obtained from electrophysiological recordings and application of knowledge to a clinical environment.
