Overview

Enterprise Systems (ES) have become increasingly popular since the early 1990s. One goal of these systems is to provide an encapsulation of core business processes and information. Many organisations have acquired ES technology, however there are considerable risks associated with ES implementation, maintenance and on-going use. In this unit, you will be equipped with the information required to inform ES adoption, selection and implementation decisions and the ability to communicate this knowledge to your peers and employers.

Task Description

This is an individual assessment for both on-campus and off-campus students. This assessment is worth 20% of the total available marks for this Unit. You will develop a PowerPoint presentation related to the learning topics in weeks one to three. Along with the PowerPoint presentation slides, you will provide scripts and a Handout.

You will include scripts as part of your PowerPoint presentation, that is, what would be said if you were giving the presentation in front of an audience. The scripts should show clearly what would be said or discussed as each slide is presented. The scripts should be included in the 'Notes' section of each slide. Handout should be designed as a supplement for the presentation in engaging the audience.
