In this unit, you will explore how research informs decision-making in criminology and related fields. You will explore the importance of strong problem-solving skills, supporting solutions with evidence-based research, and effective data analysis. You will examine both qualitative and quantitative research methods to develop strategies for addressing interdisciplinary criminology problems. In addition, you will build professional practice skills, including writing reports for a public sector audience, managing projects, and collaborating with others in a criminal justice environment. This unit emphasises the requirements of ethical research. While some activities will involve working with peers to explore research processes, all final submissions will be completed individually.
