The Australian Council for Educational Research (ACER) administers both the literacy and numeracy tests to assess whether initial teacher education students meet the requirements outlined by AITSL. This zero credit point unit will enable the tracking of your registration and completion of the tests for both literacy and numeracy. Full-time Bachelor of Education students are required to attempt the literacy and numeracy tests in their first year of study. Part-time Bachelor of Education students are required to attempt the literacy and numeracy tests in their first two years of study.
