This zero credit point unit will enable the tracking of your registration and completion of the tests for both literacy and numeracy. Full-time Bachelor of Education students are required to attempt the literacy and numeracy tests in their first year of study. Part-time Bachelor of Education students are required to attempt the literacy and numeracy tests in their first two years of study.
