This zero credit point unit will enable the tracking of your registration and completion of the tests for both literacy and numeracy. Full-time Master of Teaching students are required to attempt the literacy and numeracy tests in their first term of study. Part-time Master of Teaching students are required to attempt the literacy and numeracy tests in their first year of study.
