Overview

This unit introduces you to the design of concrete structures, including structural components such as beams, slabs, columns, footings and retaining walls. You will identify loads and load paths for gravity and lateral loading. Construction materials are also reviewed in the context of sustainability and environmental issues. You will also plan, prepare and carry out tests on structural concrete components, interpret the results and prepare test reports. You will investigate building design and serviceability requirements. Individual and teamwork focus on the development of professionalism, ethical practice, problem solving and communication.
