### Overview

This unit will introduce the student to the concept of environmental determinants of health and the need to protect people from hazards in the environment that pose a risk to health. Students will study the links between good health and the state of the environment, particularly those between the environment and society, economics and environment, politics and environment and environmental health development. Students will develop an appreciation of the interdisciplinary nature of environmental health issues and the interaction between human lifestyles, consumption patterns, urbanisation and health. It is a requirement of this unit to have access to the CQU website and the internet.

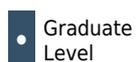

1. Full bibliographic details, presented according to the Harvard referencing style.
2. An identification of whether the article represents primary, secondary or tertiary evidence.
3. A short description of the important points in the article that make it relevant to the assignment topic.

**Note:** Each bibliography should be approximately 150-250 words in length. Start each bibliography on a new page, with

the bibliographic reference in bold type at the top of the page.

### Assessment Type

Written Assessment

### Task Description

A case study will be provided to you on Moodle. Analyse the available information and write a report clearly describing the causes and potential outcomes of the situation. In your report, identify the immediate cause of the child's faltering growth and how it could have been prevented. Explain the secondary factors potentially causing or contributing to adverse health effects, both in this particular situation and in the wider community. You should also identify any long term health or environmental effects and/or impacts on the wider community. Suggest some ways this problem could be prevented in the future. Use appropriate references from the literature to support your statements.
