General Information

Overview

Debates in the Discipline is the second of the two coursework units in the BA Honours course. The two coursework units provide discipline-context research training for the two subsequent dissertation units. You will acquire advanced research skills in your chosen discipline. Particulars of the learning materials and assessment will be negotiated with relevant staff in the academic discipline. You will engage with the trends, debates and gaps in the literature relevant to a specific Humanities or Arts discipline. In some cases, the output from this unit will be a guided literature review – for others, a guided reflection on creating an artefact creation accompanied by an exegesis or another discipline-specific document.

Term Specific Information

The Bachelor of Arts (Honours) course combines research training and a dissertation to provide graduates with advanced knowledge of the underlying principles and concepts in one or more disciplines as well as practical knowledge of research principles and methods.

With supervisor guidance in HONS28002, you will establish the boundaries of the current discipline conversation with a literature review, which will allow you to complete the HONS28001 research project proposal.

HONS28002 is designed to provide you with skills to absorb the literature on which you will contribute to knowledge or master a creative talent. You will work with your supervisor to synthesise the debates within a specific discipline.

Assessment Type

Written Assessment

Task Description

Writing a literature review is a complicated task since they come in different types and sizes! Being steeped in the 'debates of the discipline' is the springboard from which your research project begins a journey.

Further, several concepts and processes of critical evaluation need to be considered when examining the body of knowledge related to your research project. Importantly the literature review is crucial to identifying the research questions and how research methods are used to achieve the planned results.

Your literature review becomes a chapter of your Honours Dissertation. You should note that the final form of the literature review in your Honours Dissertation will probably be modified by the progress of the two research units HONS28003 and HONS28004. Further, the early reading of the related literature will inform and help complete the project proposal of HONS28001.

Your literature review (or discipline-specific equivalent) should be around 4,000 words and contain:

- A literature review/ rationale that demonstrates the currency of the topic.
- A critical analysis of relevant primary texts.
- A rationale for the proposed research methodology.
- In some cases, applicable conceptual modelling or mind mapping.

The structure, design and format of the literature review will be informed by discussion with your supervisor to account for discipline specifics.

This writing task is a pass/fail grade.
