# 2 Take Home Paper

# **Assessment Type**

Take Home Exam

#### **Task Description**

The take-home paper will consist of a number of legal problem and short answer questions that test your knowledge and understanding of legal principles, legislation and cases. It is an individual assessment task and no collaboration is permitted. It will be released on Moodle. Students will have 24 hours to complete and submit their answers via Moodle. Extensions for the take-home paper are only permitted in accordance with relevant university policies.
