# Overview

LAWS13009 Corporations Law examines the various business structures available under Australian law, with a particular focus on companies. Topics include partnerships, corporate personality; the incorporation process; the corporate constitution; company contracts; administration of companies and management of the business of companies; duties and liabilities of directors and officers; share capital and membership; members' remedies; company credit and security arrangements; and winding up of companies. This unit meets the LPAB requirements for company law.

# Feedback, Recommendations and Responses

# Feedback from Internal review

#### **Feedback**

An internal review of the unit suggested that the level of difficulty may fall short of what is required for a third year unit.

#### Recommendation

1. The unit coordinator should review the level of difficulty of the assessments to accord with third year standards. 2. The unit coordinator should review the presentation and content of the tutorial problems to challenge the students more.

Feedback from Student feedback, observation of students performance and students' expressed expectations.

#### **Feedback**

Because of the authentic nature of the assignment, students have difficulty tracking where they are at in terms of progress towards the exam (which is a different style of assessment).

#### Recommendation

The weekly quizzes should be converted to Practice Quizzes on the Moodle site, making them more prominent as a learning tool and providing a running record of their results in the Gradebook. Students should be encouraged to do the weekly quizzes to monitor their progress.

## **Task Description**

The take-home examination will be set to take place in or around the standard examination week at the end of term.
