## General Information

### Overview

Organisations are legal as well as economic entities. Managers are legally required to advance the interests of the organisation, yet firms and businesses operate in a diverse range of environments and as such require different governance systems. In this unit you will address the legal status of organisations and the corporate governance structures that should be established to ensure company directors and managers fulfill their legal and ethical obligations. You will consider international conventions and agreements from organisations such as the United Nations, the International Labour Organisation and the Organisation for Economic Co-operation and Development and how these influence legislation within different countries. You will examine the day-to-day legal and management issues faced by organisations, such as employment law, anti-discrimination and OH&S requirements, so that organisations act responsibly and ethically. The unit seeks to increase your awareness and understanding of the legal risks associated with management and business decision making.

Presentation

#### Task Description

Students are to select a recent corporate governance failure in Australia and obtain permission from the unit coordinator to use the topic for the presentation and written report. Students will submit a professional 15-minute oral presentation that is supported by Power Point slides or other visual aids. The presentation will provide an overview of the governance failure, identify how the organisation's business activities and ethics contributed to the governance failure and describe the impact of the failure on the company and relevant stakeholders.

#### Assessment Criteria

The format of the presentation will be assessed according to the following criteria: ability to deliver a concise and structured introduction, main presentation and conclusion that meets professional standards in the use of audio-visual aids and verbal communication.

The content of the presentation will be assessed according to the following criteria: the ability of students to accurately summarise and explain the governance failure, the impact of the organisation's business activities, ethics and culture on the governance failure and how the governance failure effected the company and its stakeholders, for example reputation, share value and employees. ## 2 Corporate Governance Failure Report

### Assessment Type

### Task Description

The written report will require students to examine in greater detail the case study of corporate governance failure submitted in presentation. Students are required to write a detailed and properly structured report that a legal expert would provide to the audience in the presentation in assessment task 1. The report requires students to provide a summary of the governance failure, describe how the organisation's policies, culture and ethics contributed to the governance failure, evaluate the responses by the organisation and relevant regulatory actors and advise which corporate governance strategies the organisation could implement to minimise the risk of future governance failures.

## **3 Practical Assessment: Wage Theft in Australia**

### **Assessment Type**

Practical Assessment

### **Task Description**

Students are to select an organisation that has recently engaged in the underpayment of wages of employees ('wage theft') in Australia and obtain permission from the unit coordinator to use the topic for the practical assessment. The practical assessment requires students to choose three online research sources related to the organisation's business ethics and corporate social responsibility, for example, a credible and accurate media report, an organisation's policy or code of ethics, an industry code or a regulator's report or press release. Students are required to describe the business ethics and corporate social responsibility issues raised in the three research sources and connect these issues to the laws, theories and principles raised in this unit.

Students who engage in contract cheating also risk being blackmailed by contract cheating services.

### What can you do to act with integrity?



#### Be Honest

If your assessment task is done by someone else, it would be dishonest of you to claim it as your own



#### Seek Help

If you are not sure about how to cite or reference in essays, reports etc, then seek help from your lecturer, the library or the Academic Learning Centre (ALC)



#### Produce Original Work

Originality comes from your ability to read widely, think critically, and apply your gained knowledge to address a question or problem
