General Information

Overview

This work integrated learning unit builds on the knowledge, skills and professional behaviour developed in CM18 Master of Laboratory Medicine. Theoretical and technical knowledge will be applied to a professional work environment in a specialised field of diagnostic Medical Laboratory Science. You will develop technical skills and analyse the outcomes to meet the competency and skill required of an entry-level Medical Laboratory Scientist. You will perform, and reflect on, safe operations and quality management in the medical laboratory, with due regard for legislation, regulation and accreditation. Behavioural aspects of professional practice are emphasised and you are expected to reflect on your own communication, decision-making and team-work skills. Critical appraisal of performance will enable you to attain competency in your professional, technical and analytical skills. You will be required to undertake a minimum of 560 hours of clinical placement (16 weeks full-time equivalent) as per the Australian Institute of Medical and Clinical Scientists (AIMS) accreditation requirements.
