You will further develop your clinical reasoning and decision-making skills as you take on more independence in performance, operating within your scope of practice. You will perform in accordance with the code of conduct for regulated health professionals in Australia. You will further develop your clinical foundation knowledge of techniques, patient care requirements and safety considerations of magnetic resonance imaging (MRI).
