Overview

The unit is designed to familiarize students with the world of entrepreneurship, innovation and start-ups. It examines the nature and roles of entrepreneurship, innovation and the entrepreneur in society. You will identify the key factors for entrepreneurial success and how to evaluate these factors. You will also learn the stages that entrepreneurs go through in taking the seed of an idea through to planning for the growth of a successful business. Emphasis is placed on planning, financing, starting and managing new start-ups.

1 Assessment 1: New enterprise idea and feasibility study

Assessment Type

Written Assessment

Task Description

This is an **individual assignment** that requires you to write an essay of 1800 words (+/- 10%). This assessment item provides you with the opportunity to learn how to identify and analyze a business idea using your understanding of the theoretical concepts covered in this Unit. The assessment aims to develop your critical thinking, research, and written communication skills. This assignment requires you to identify a new business idea that has the potential to be launched as a social or commercial enterprise in the future. In doing so, you are required to:

1. Provide a brief description of your new business idea.
2. Discuss the process you followed to develop your new business idea.
3. Review academic literature in this area and describe the skills needed to be a successful entrepreneur.
4. Evaluate the viability of your idea through a feasibility study.
5. Review academic literature in this area and examine the importance of your idea.

Assessment Criteria

New enterprise idea and feasibility study (40% weighting, i.e. 40 marks)

1. Provision of a description of the idea or opportunity (6 marks).
2. Identification of the process followed to develop the business idea or opportunity (6 marks).
3. Discussion of the skills needed to be a successful entrepreneur (6 marks).
4. Evaluation of the viability of the proposed social or commercial enterprise through a feasibility study and concept statement. (10 marks).
5. Explanation of the importance of the proposed enterprise within society (6 marks).
6. Quality of essay and literature: Demonstrated depth and quality of research by using a minimum of 10-12 relevant academic scholarly sources (journal articles and book chapters) and a minimum of 5-6 industry sources (news articles, websites, industry reports) **using the APA referencing style**. And correct use of the essay structure and appropriate conventions of academic writing. (6 marks).

2 Assessment 2: Business Plan for your new business idea

Task Description

This is an **individual assignment** that requires you to write a **professional business plan report** of a maximum of 3000 words for your new business idea. This word limit includes an executive summary (500-800 words) and the main report (2200- 2500 words). Appendices, cover page, table of contents, list of figures/tables, and references are not included in the word count.

Assessment Criteria

Business Plan Report (60% weighting, i.e. 60 marks)

- Executive Summary (5 marks)
- Description of the proposed new business idea, compelling justification for the 'need' of the new enterprise and its value proposition (10 marks).
- Discussion on the legal organisation structure (and/or any intellectual property plan, if applicable) for your proposed new enterprise (2 marks).
- Business Plan elements - Ability to formulate a business plan by including the required key elements like industry, target market, competitor analysis, financial plan (budget), marketing and operational plan. In addition, a compelling explanation of the business plan elements (25 marks).
- Use of the business model canvas to illustrate elements important to developing a new enterprise (10 marks).
- Quality of report and literature: Demonstrated quality of research using relevant academic and industry sources, correct use of the APA referencing system, correct use of academic report structure and appropriate conventions of academic writing (8 marks).
