As you further enhance your singing technique, you will explore the phonetic aspects of the Spanish and Singaporean languages through selected songs and vocal exercises. The unit integrates your learning of singing with music theory, aural musicianship and piano keyboard, covering intermediate concepts of pitch, harmony, rhythm, pulse, tempo, articulation and expression to extend your technical and artistic development.
