Previous Student Feedback

Feedback, Recommendations and Responses

Every unit is reviewed for enhancement each year. At the most recent review, the following staff and student feedback items were identified and recommendations were made.

Feedback from Unit evaluation

Feedback

Students felt that the ALC lectures should be recorded.

Recommendation

ALC is an integral component of the curriculum. Tutorials are live to enable student engagement. A request has been made for ALC to record lectures for term 2. Recommendation

The moodle site for this unit has undergone significant redesign since term1 to enhance the student experience. As well as changing the images the following changes have been made to term 2 NURS11159 moodle site: 1. Visually more appealing and with a cleaner approach to foster a positive attitude to study and streamline resources available to students. 2. A table containing all zoom links for each tutorial to improve efficiency around finding the link. 3. Weekly content revised and reduced to eliminate repetition. 4. Weekly reading resources categorised into "essential" reading and "supplemental" reading. This is to improve the student experience and reduce the feeling of being "overwhelmed" by 10-20 resources each week. 5. Weekly tabs identifying the week's content.

Assessment Type
Written Assessment

Task Description

This task assesses the following unit outcomes:

1. Discuss historical and contemporary factors that have influenced the image, status and practice of nursing.
2. Examine the principles of communication theory and professional communication in various mediums to provide accurate and concise information.
3. Associate the role of professional governing bodies in relation to professional nursing practice, patient safety and governance.

Background:

The Nursing and Midwifery Board of Australia (NMBA) uses professional codes, guidelines and policies to guide Registered Nurses in their practice. These also apply to students of nursing.

The task:

You are required to write a 1500 word essay (+/- 10%) that includes an introduction, three body paragraphs and a conclusion.

To complete this assessment, you must watch the video of Stanley located on the NURS1159 Moodle site. After watching the video identify how the nurse caring for Stanley has failed to comply with the Code of Conduct for nurses (NMBA, 2018).

In this essay, you are required to identify three instances where the nurse caring for Stanley has failed to comply with the Code of Conduct for Nurses (NMBA, 2018). You are to explain, in your own words, the meaning of each of the three codes that you have identified. Discuss correct nursing practice in relation to each incident. Support your discussion with references from the literature.

Planning:

Planning is crucial to writing effective academic essays. An essay plan has been created for you (below) to illustrate how to plan an essay. In future units you will be required to formulate your own essay plan.

Use the template below to assist you to write your essay:

- **Introduction** (approx. 150 words)

- **Paragraph 1:** - Instance 1- Identify how the nurse caring for Stanley has failed to comply with the Code of Conduct for Nurses (NMBA, 2018). In your own words, explain what that code means. Discuss correct nursing practice in relation to this incident. Support your discussion with references from the literature (approx. 400 words).

- **Paragraph 2:** Instance 2- Identify how the nurse caring for Stanley has failed to comply with the Code of Conduct for Nurses (NMBA, 2018). In your own words, explain what that code means. Discuss correct nursing practice in relation to this incident. Support your discussion with references from the literature (approx. 400 words).

- **Paragraph 3:** Instance 3- Identify how the nurse caring for Stanley has failed to comply with the Code of Conduct for Nurses (NMBA, 2018). In your own words, explain what that code means. Discuss correct nursing practice in relation to this incident. Support your discussion with references from the literature (approx. 400 words).

- **Conclusion** (approx. 150 words)

An academic paper is required to be written in the third person using the APA referencing style. This paper must include contemporary literature to justify your statements and to support your discussion.
