## Recommendation

As the assessment is based on completing a clinical review of a case study an example would in fact simply give the responses, however further development of additional case studies is in the works and each of theses will have examples of the client assessment that should in fact provide guidance. Rather than a specific example an Assessment Information Package is produced and made available for all students each term. As well as giving overall advice on referencing, academic writing, paraphrasing and more it also has each assessment broken down in to component parts and includes frequently asked questions, hints and tips, referencing requirements specific to each task.

# 1 The role of stigma in the treatment of Mental Illness

## Assessment Type Written Assessment

### **Task Description**

Assessment 1: The stigma associated with Mental Illness has often been called a barrier to treatment. Assessment one is asking you to examine ideas in terms of the history of the stigma of Mental Illness. How it does present as a barrier to care? How is this being overcome from an Australian perspective? Is the work around stigma reduction effective?

## The Task:

Using up to date literature (a minimum of 10 individual citations) and no more than 1500 words respond to the above questions.

In your response some things to consider may be:

- History and prevalence of mental health in the general population
- The number of hospital admissions each year for mental health issues and how this differs from past treatments of Mental Illness
- Public awareness campaigns.

Other areas to also consider include:

- Current and past suicide rates
- Response to care
- The impact that the Recovery Approach has had on treatment.

This is not an exhaustive list but a few ideas to get you started.
