# Overview

In this unit, you will have the opportunity to practice nursing care in the medical-surgical environment. You will apply the Nursing and Midwifery Board of Australia (NMBA) Registered nurse standards for practice (2016). You will continue to explore the importance of the National Safety and Quality Health Service (NSQHS) Standards (2017) to all nursing practice in Australia and use the Patient Safety Competency Framework (PSCF) (Levett-Jones et al., 2017) in your practice as a nursing student. You will be expected to identify risk and recognise and respond appropriately to the deteriorating patient in the simulated and clinical environment. You will work within your scope of practice using the decision-making framework (DMF) (NMBA, 2020). You are required to participate in a compulsory three (3) day residential school prior to attending professional experience placement for this unit. This unit includes a 120 hour block professional experience placement in a medical-surgical environment. You must meet specific mandatory health, safety and security requirements to be eligible to attend each professional experience placement. Professional experience placements may be limited in your community and you may be placed in other locations. Please be prepared financially and personally to cover the costs to relocate for placements. Due to the limited availability of placements, some block placements have start and/or end dates that fall outside standard term dates.

# Feedback from Student evaluation survey

### Feedback

I think it would be better to have residential school weekly to allow more in-depth engagement and practice with the knowledge and skills. I understand covid played a part in this, however, I believe a return to weekly residential school lessons would be a better option as soon as possible. The pre-brief setup was not great either. I managed to complete everything prior to residential school but could understand if others were not able to.

### Recommendation

Internal classess are offered on some campuses, and these are more spread out than residential schools. However, timetabling of multiple units and three separate courses including HE, VET and Individual support limit the ability to offer weekly classes for all students. The content in the pre-brief will be condensed as this unit now will go back to Pass/Fail and only three assessments not five.

# Feedback from Student Evaluation survey

### Feedback

I found the workload in this subject big. The pre-brief work was huge, 3 weeks placement, res school and 2 big written assessments. I don't like that we are graded on just the 2 written subjects so we could fail the subject but have an awesome placement. I also found the second written assessment we had not a lot of prior learning about but were asked to write about the anaesthetic nurse. Maybe one written piece would be better in the future. Prior placement subjects have been pass/fail which I find more fair because it covers all the assessment components of the subject instead of being graded just on two written pieces for the whole subject grade.

### Recommendation

The five assessments and this unit being graded has been revised for 2022. The five assessments have been reduced to three assessments and no written assessments. The unit is being revised from graded to Pass/Fail.

If you fail to achieve 100% in your first attempt, you must speak with a unit coordinator and a resit will be arranged on day 2 of your residential school. If 100% is not obtained in your second attempt, you will be required to undertake remediation with ALC numeracy before your third attempt will be opened. You will have a maximum of **Three (3) attempts** only to secure 100% and a PASS.

Failure to achieve 100% after three (3) attempts may result in a Fail grade and you may not be able to progress to clinical placement.

**Aim:** The aim of this assessment is to enable you to demonstrate your ability to apply the learning from the unit, and NMBA Registered nurse standards for practice. You will perform assessment, planning, implementation, and evaluation of patient care and will safely recognise and respond to the deteriorating patient prior to the commencement of the Professional Experience Placement.**Instructions:** This Clinical Skills Assessment will be based on skills covered during residential school sessions. To attain a pass, you must achieve all the following components for each skill:

- $\circ\;$  demonstrate the 5 moments of hand hygiene and infection control principles.
- $\circ\;$  recognise and respond to acute patient deterioration as per the simulation scenario.
- demonstrate safe and timely administration of medication adhering to the 5 rights of medication administration and 3 checks. 3 patient identifiers are used prior to administering the medication.
- $\circ~$  undertake NURS12161 Professional Experience Placement 2 clinical procedure as per the checklist.
- $\circ~$  effectively communicate with the patient in a person-centred approach.
- $\circ\;$  demonstrate the application of the ISBAR communication technique.
- $\,\circ\,$  apply legal principles of professional documentation in the bedside chart.

**Portfolio instructions:** Medication safety, Inpatient Medication charts and Bloodsafe. Please see the Unit Moodle site for the NURS12161 Professional Experience Placement 2 detailed marking guide to be used by the clinical assessor.

#### **Requirements:**

- This assessment will be a simulation assessment activity focusing on your clinical abilities and safe nursing practice. You will undertake one of four scenarios. The scenarios are available in the NURS12161 Moodle site. Time allocated to complete this assessment is 20 minutes. The Clinical Skills Assessment will be held during the last week/day of your residential school.
- You will be advised on the day if you have been successful in your Clinical Skills Assessment. A maximum of 3 attempts at achieving this assessment will be permitted. If a second attempt is required, you will reattempt at residential school. If a third attempt is required, you will be given a different scenario and a 20-minute video recording will need to be submitted to the Moodle site within 3 days of completing your residential school and before you are due to commence placement. If you are not successful on the 3rd attempt, you will not be able to proceed to clinical placement and will receive a Fail for the unit.
- You are required to complete online training packages and upload certificates as a part of your Assessment 2 clinical skills test.
- Medication Safety 2022- Single certificate is obtained after the completion of all 7 modules and 2 case studies (Mr F & Mr L)
