The rating scores range from 1 to 5. 5 = very good, 4 = good, 3 = satisfactory, 2 = poor, 1 = absent.

In appraising a poster, give only one rating to each criterion. If an item is non-applicable circle and write N/A. After you have responded to all the items, tally each category to obtain a sub score. Then add the two sub scores to obtain the grand score. A higher score indicates a better quality of poster. Finally consider your numerical ratings as well as any written comments and complete a summary statement, highlighting the strengths and limitations of the poster.

- · The time and personnel required for data collection
- · The format for reporting findings
- · The timeframe for completion and reporting
- · Recommendations from audit findings

Present a report of your findings at your local area. It can be:

- · A poster and verbal presentation summary of report information this will include our poster from assessment one
- · A power point presentation to summarise report
- · A written report presentation within a group discussion
