1 Ethics Discussion Paper

Assessment Type Report

Task Description

In this assessment, you will develop an Ethics Discussion Paper that discusses the ethical considerations that are specifically related to the project you will undertake for NURS20174 Nursing, Midwifery and Social Sciences Project 2.

In writing this discussion paper, you will compile some of the necessary information required to complete an ethics application for your proposed research project.

Please follow the following steps to complete this assessment:

- 1.0 Download the National Statement of Ethical Conduct in Research. This document will guide you in identifying important ethical considerations for your project.
- 2.0 Provide a discussion paper of 1000 words which identifies and discusses the management of specific ethical issues relating to your proposed project that you will carry out in NURS20174. Include a brief and general explanation of the importance of ethical conduct (1 paragraph).
- 2.0 Construct an information sheet which could be used in your research. Examples can be found on the CQUniversity Research Moodle site.

Literature and references

Please use quality references to support your discussion. Suitable references include peer-reviewed journal articles as well as textbooks and credible websites. When sourcing information, consider the five elements of a quality reference: currency, authority, relevance, objectivity, and coverage. Grey literature sourced from the internet must be from reputable websites such as from government, university, or peak national bodies, for example, the Australian College of Nursing.

Requirements

- Include a cover page providing your name, the name and code of the unit, and the title of the assessment.
- Use size 12 Times New Roman or Arial font with 1.5 line spacing and 2.54cm page margins.
- Include page numbers, name and student number on each page in a footer.
- Use American Psychological Association (APA) referencing style. The CQUniversity Academic Learning Centre has an online APA Referencing Style Guide.
- The word count is considered from the first word of the introduction to the last word of the conclusion. It excludes the cover page and reference list. It includes in-text references and direct quotations.

2 Project Research Proposal

Assessment Type

Research Proposal

Task Description

Aim

This assessment involves developing a research proposal that will guide you in conducting the study you will undertake for NURS20174 Nursing, Midwifery and Social Sciences Project 2.

This assessment will allow you to apply the knowledge and skills you have gained from NURS20168 Designing Research in Nursing, Midwifery and Social Sciences. You will develop a plan for a research project directly related to your field of practice or area of work. It is important that this project (that you will go on to conduct in NURS20174) is a low-risk quality study that requires only coursework ethics approval.

The Task

Develop a research proposal that investigates an appropriate research question from your area of work or practice. The proposal will need to include the following sections:

- 1.0 ABSTRACT The abstract is designed to give the reader a 'snapshot' that summarises the entire research plan/proposal. It should contain the purpose of the study (aims/objectives); basics of the research design; significance of the proposed research and/or the proposed contribution to the body evidence around your chosen topic/field/area of interest.
- 2.0 TABLE OF CONTENTS Please follow these instructions to insert a Microsoft Word auto-generated table of contents.
- 3.0 INTRODUCTION The introduction should clearly inform the reader of what you are intending to investigate. Please include the following:
- The background to your project.
- The context for your investigation.
- A clear statement of the overarching purpose to the duty. This includes stating the research problem.
- A clear rationale or justification why is this an issue or problem that needs to be investigated or researched?
- The importance or significance of what you are proposing to do (sometimes referred to as the "So what?" factor)

- 4.0 AIMS/OBJECTIVES The aim/s state/s the purpose or the intent of the project what you want to achieve. The objectives identify the research outcomes necessary to achieve the aims. The outcomes are specific, clearly defined and observable or measurable. The aims/objectives are generated by the overall research question.
- 5.0 RESEARCH QUESTION and/or HYPOTHESIS For the size of this project proposal you will generally only need to articulate your aims/objectives with one research question. The research question guides your study and allows you to answer the research problem. The research question needs to be clear, focused and feasible in the time frame given for this assessment (12 weeks).
- 6.0 LITERATURE REVIEW The literature review demonstrates your knowledge of the topic and provides a rationale and justification for why this is an important area to research. The literature review needs to include the most current evidence about the topic along with any gap that has been identified in earlier research or studies on the topic. You need to state clearly how the project you will undertake will make a difference to the area of focus.
- 7.0 RESEARCH DESIGN/METHODOLOGY/METHODS This is where you discuss your research approach and the overall methodology that you have selected to answer your research question. The methods you will use to collect and analyse data will also be discussed. You will need to justify why this is the best approach and method to take to answer the research question. Ethical considerations need to be addressed and discussed here.
- 8.0 LIMITATIONS Limitations are the influences that the researcher cannot control. They are the short-comings, conditions or influences that may place restrictions on the methodology and results.
- 9.0 CONCLUSION This is a summary of the key points made and includes a concluding statement of the main ideas put forward in this proposal.

When sourcing information, consider the five elements of a quality reference: currency, authority, relevance, objectivity, and coverage. What is a breach of academic integrity?

A breach of academic integrity includes but is not limited to plagiarism, self-plagiarism, collusion, cheating, contract cheating, and academic misconduct. The Student Academic Integrity Policy and Procedure defines what these terms mean and gives examples.

Why is academic integrity important?

A breach of academic integrity may result in one or more penalties, including suspension or even expulsion from the University. It can also have negative implications for student visas and future enrolment at CQUniversity or elsewhere. Students who engage in contract cheating also risk being blackmailed by contract cheating services.

Where can I get assistance?

Be Honest

If your assessment task is done by someone else, it would be dishonest of you to claim it as your own



Seek Help

If you are not sure about how to cite or reference in essays, reports etc, then seek help from your lecturer, the library or the Academic Learning Centre (ALC)



Produce Original Work

Originality comes from your ability to read widely, think critically, and apply your gained knowledge to address a question or problem
