## Overview

This unit will provide students with knowledge and understanding of aetiology and pathogenesis of diseases and epidemiology as a foundation for clinical practice in Years 2 and 3. Students will be able to appreciate the impact of systemic disease on the health of the oral cavity, and in the association between oral disease and systemic disease. Students should be able to recognise and identify oral pathological conditions in the clinical situation and explain the principles of a comprehensive dental examination, risk analysis, screening of diseases and referral for complex care outside one's scope of practice for children and adults. Lastly, students will be able to communicate information regarding oral health in oral and written forms in terms of relevant interpersonal / team communication skills and professional attitudes and ethical behaviours.

The choice of dental practice must be approved beforehand by the Unit Coordinator and a Clinical Placement Agreement signed by both parties before the commencement of the clinical placement. Evidence of Mandatory Checks must be completed prior to Clinical Placement. Documents for Mandatory Checks and Clinical Placement agreement must be uploaded to SONIA. Links for the documents and for SONIA are on Moodle. You will complete a Self-Assessment of their performance in this task. The Clinical Supervisor will complete the Student Record of attendance and comments.

A bound copy of the clinical placement workbook will be available at residential school or online in Moodle. The practical tasks include exercises in intra-oral and extra-oral examinations, saliva testing and diet evaluations . The written component will be a series of short answer questions on topics covered in weeks 1-12. The questions are designed to encourage students to look further than the textbook and research the answers. All questions will have clinical applications
