This will be specifically designed and contractually agreed upon with the University and industry partner. The placement will enable you to apply your knowledge of public health program planning and evaluation, whilst developing an understanding of the professional requirements of working as a public health, health promotion or environmental health specialist.

4 Reflective essay/ Project

Assessment Type

Task Description

Health Promotion Students: Write a reflective essay based on their experiences of working in health promotion during their industry placement. Please see Moodle site for more information.

Environmental Health students: Students will conduct an environmental health project as part of their practicum and in collaboration with your industry partner. You will need to submit a project proposal with an ethics application attached for approval prior to commencing your project (Part A). At the conclusion of your project, write a project report, using an appropriate format for publication OR presentation to Council. Please see the Moodle site for more details and discuss with the Unit Coordinator if you need further assistance.

Students participating in approved CQU Public Health overseas mobility projects: Write a reflective essay describing how you applied the theoretical knowledge you have gained through study to the work you conducted in-country. Reflect on how this knowledge assisted you, and any modifications or changes you needed to make when practising in real life. Consider how the experiences impacted on you personally and as a global citizen.
