Overview

Public Health Project Work 2 is the third of a suite of four units designed to allow you to undertake a work-related or research project over the course of two terms. The project may be related to a public health intervention, evaluation or research topic. This unit will allow you to undertake the relevant work associated with data collection and analysis, reflexivity and management of a project.
