### Equipment Requirements for Recording Projects

Performance and Production Studies students require some very specific equipment to facilitate the recording requirements of this unit.

This unit provides training in performing recording and mixing music. Because of this, you will need to have access to the following:

- *Ableton Live* software
- An audio interface
- Your instrument
- A quick stable internet connection (preferable ethernet)
- Microphone or instrument lead
- Studio headphones and your computer / webcam

### About Ableton Live

*Ableton Live* is an industry standard DAW (digital audio workstation) and learning how to use it is extremely beneficial. You will be required to submit *Ableton Live* sessions as part of your assessments and therefore need to have access to a copy of *Ableton* software. As the production classes are based on the *Ableton* software, no other DAWs are acceptable for this unit. A free 90 day full use trial version of the *Ableton Live* software is available for download from the *Ableton Live* website
