## **General Information**

#### Overview

This unit will introduce you to advanced clinical assessment, combining the skills of clinical history taking with those for physical examination, whilst incorporating knowledge of cultural and linguistically diverse populations. You will synthesise clinical information while integrating underpinning knowledge of common pathologies and pathophysiology in the critical care context. You will be able to formulate an appropriate clinical management plan to treat the critically ill or injured and employ reflective practice principles to effectively revise ongoing management plans as required. You will also critically reflect upon the leadership skills required at a critical care level.

# Assessment Tasks

### 1 Case Presentation

#### **Assessment Type**

Written Assessment

#### **Task Description**

#### **Preamble**

In the critical care context, you will formulate an appropriate clinical management plan based on clinical assessment findings, underpinning knowledge and evidence-based medicine. You will be required to engage in reflective practice principles to revise ongoing management of the critical care patient and develop leadership skills at a critical care level within a clinical team environment.

#### **Task Description**

In this assessment, you will need to create a PowerPoint case presentation of a patient who was assessed and treated during your experience as a clinician and required or received prehospital management at a critical care level. Your presentation must include the following information:

- · A brief introduction to the case.
- · The clinical assessment findings of the case.
- · The Clinical Management Plan (CMP) that was implemented.
- · Reflection on the management provided to this patient.
- · Discussion on the patient assessment required at a critical care level and a revised CMP for this patient at a critical care level, including ongoing management, justified by the inclusion of evidence-based medicine.
- · Reflection on the leadership traits that were demonstrated in the management of this patient and the identification of the leadership skills required to treat this patient at a critical care level.

### **Assessment Criteria**

The presentation will be assessed in accordance with the rubric and information provided on the unit's Moodle page. The following criteria are key points to be included:

- The presentation should be in a PowerPoint format.
- Recorded narration is required and you can use the Notes section to detail your thinking.
- The presentation must address each of the main topic tasks as detailed in the task description.
- Avoid superficial points or comments.

As this is a presentation, you should include images where appropriate, but these must be referenced.

The presentation has no specified length in regards to the number of slides used but the recorded presentation should be approximately twenty (20) minutes.

This presentation is worth 40% of your overall unit mark.

## 3 Portfolio

#### **Assessment Type**

Portfolio

#### **Task Description**

#### **Preamble**

In a critical care context, you will need to demonstrate the ability to undertake a comprehensive clinical assessment, including history taking and physical examination and synthesize clinical information while integrating underpinning knowledge of common pathologies and pathophysiology. In addition, you will need to formulate an appropriate clinical management plan based on clinical assessment findings, underpinning knowledge and evidence-based medicine and engage reflective practice principles to revise ongoing management of the critical care patient. You also need to develop the leadership skills required at a critical care level within a clinical team environment.

## Task description

In this assessment, you will need to complete a clinical portfolio of a minimum of three (3) patients, who were assessed and treated during your recent experience as a clinician. The format of your portfolio can be self-determined, however, it must include the following for each case:

- · The patient's clinical presentation, history, assessment and clinical findings
- · Deliberation on the possible differential diagnoses for the patient.
- Examination of the connection between the patient's clinical presentation and assessment findings with the pathophysiology of the most likely definitive diagnosis.
- · Reflection on the Clinical Management Plan used in the treatment of this patient.
- · Discussion and reflection on what further assessment and management could have been undertaken at a critical care level and the leadership skills that would have been required at a critical care level in the treatment of this patient. All medical practice discussed must be justified with presented evidence (This does not include your service's Drug Therapy Protocols and Clinical Practice Manuals, though they should still be included if applicable.).

The portfolio will be assessed in accordance with the rubric and information provided on the unit's Moodle page. The following criteria are key points to be included:

- The portfolio should be presented in an essay format.

- Avoid superficial points or comments and be clear and concise.
- As this is a written assessment, you must include in-text referencing and a reference list.

There is a minimum word count of 1500 words per case (minimum of 4500 words in total) and a maximum of 2000 words per case (a maximum of 6000 words in total).

This portfolio is worth 40% of your overall unit mark.
