Students will be required to apply high-level clinical reasoning to arrive at appropriate diagnoses relating to complex clinical scenarios and to develop, justify, and evaluate appropriate assessment and management strategies. Students will apply principles of interdisciplinary practice and will further refine their skills in clinical reasoning and reflective practice.
