This unit is an introduction to professional property valuation. Practical aspects of property valuation are introduced including data collection, valuation report writing, the practical implications of professional ethics and codes of professional practice in property industry with specific focus on simple residential property.

Feedback

Generative AI has been shown to successfully complete some forms of authentic assessment, challenging traditional assumptions about the capacity of assessment tasks to reliably demonstrate individual student achievement.

Recommendation

The assessments in this unit, particularly Assessment Task 1, are progressively developed and applied to individual real-world properties. Consistent with contemporary industry practice, some components can be effectively supported by generative AI tools. However, key aspects still require the professional judgement, analysis, and expertise of a human valuer. To better reflect these distinctions, the assessment instructions and rubric will be refined to place greater emphasis on the human-centred elements of the valuation process, including selecting appropriate valuation approaches, critical analysis, professional judgement, and the interpretation of evidence.
