The Proposal needs to be passed by the Supervisor in conjunction with Course coordinator in order to progress the thesis. The supervisor also needs to endorse the continuation of the project through to the Thesis II subject.

Assessment Criteria

See Guidelines for Master of Clinical Psychology Thesis that was sent out to all prospective students and is stored in the Wellness Centre Manuals drive. It is understood that specific projects may, for a range of reasons, not have met all expected timelines.

It remains however the responsibility of the supervisor to endorse the continuation of the project through to the Thesis II subject. If the proposal is not passed by the supervisor and the course coordinator, then a second review of the proposal will be sought. If the second reviewer concurs with the initial supervisor then the student will be required to withdraw

from the Thesis I subject and will not be permitted to enrol in Thesis II of that academic year.
