You will work under supervision to finalise and submit your research thesis thereby developing the research skills necessary for working as a Clinical Psychologist.

Assessment Type

Thesis/Dissertation

Task Description

Students are required to submit the thesis as a single PDF document. The thesis (introduction, methods, results and discussion) should be between **6,000-8,000 words**, not including abstract, tables, figures and references. The thesis formatting should be consistent with APA-7 style.

The submitted thesis needs to include each of the elements described below.

- 1. Cover page
- 2. Statement of originality
- 3. Acknowledgements
- 4. Data storage statement
- 5. Table of contents
- 6. Abstract
- 7. Introduction
- 8. Method
- 9 Results
- 10. Discussion
- 11. References
- 12. Appendices (must include the final ethics report or a statement from the supervisor that this is not required).

Note that tables and figures should appear in the text as soon as practicable after they are first mentioned.

Assessment Criteria

The thesis will be graded by two examiners and graded for each section:

- 1. Title and Abstract
- 2. Introduction
- 3. Method
- 4. Results
- 5. Data Screening and Assumption Testing
- 6. Discussion
- 7. Style, Referencing, and Written Expression.

The guide that is provided to the thesis examiners to detail the required standards for each grade level within each section of the thesis is available on the unit Moodle page. The results from the two examiners will be reviewed by the

unit coordinator. If these two scores are separated by less than an academic grade an average score will be used as the final grade. Where more than one grade band separates the two examiners 'results, then a third examiner will be sought. The final grade will then be the average grade of the two most aligned results as determined by the unit coordinator and the third examiner.

All theses will be subject to 'Turn It In' analysis. The thesis will be awarded an overall grade as follows: High Distinction (85% +) Distinction (75-84%) Credit (65- 74%) Pass (50-64%) Fail (Less than 50%).
