Overview

This unit covers topics related to occupational health and wellbeing in organisations, emphasising the principles of good work design and the integration of occupational health and safety, health promotion, wellness, work design and productivity. Topics include common occupational health hazards such as manual tasks and sedentary work behaviours, as well as psychosocial hazards such as workplace bullying, occupational violence, shift work and fatigue, which lead to occupational stress.

It is noted that assessment tasks will need to be reviewed based on student feedback this term to ensure that better instructions are provided on how to complete assessment tasks.

While the assignments were based on real world scenarios, they were marked as academic papers e.g. a leadership team would not be interested in references (other than legislation and resources) and would appreciate brevity. This aside, Professor Klockner was extremely knowledgeable and great learning facilitator.

Recommendation

Some students did not understand the expectation that academic assignments in this unit, whilst requiring thinking about practice, still require in-text referencing. It is therefore recommended that the assessments be reviewed to consider how they can be better tailored towards ensuring theory (with referencing) translates into practice for student tasks. Furthermore, it is recommended that each assessment task has a stated requirement for the number of peer reviewed journal article references expected to be used to support students' written work, and that this is incorporated in the marking rubric.

Feedback

This was a thought-provoking unit, given its application to my workplace. I was able to frame the content and the unit's assessments to address what I had been seeing and feeling from my colleagues. I really enjoyed this subject.

Recommendation

Students like the workplace context-based assessment tasks and get to explore an area of interest within their own workplace. It is recommended to keep the practical nature of the assessments but make some theory into practice changes so that students also explore the academic literature more on their chosen topic.
