General Information

Overview

As the first unit of the intermediate second year level in this series, you will continue the systematic progression of the ideas and expressive practicum in the realisation of theatre performance, by undertaking more complex activities according to your specialisation in either Music Theatre, Drama or Technical Theatre. If you are in the Music Theatre specialisation, you will concentrate on synthesising the three areas of acting, music and dance, in exercises designed to establish the basics of harnessing and focusing your expressive ability through self-awareness and examining the concept of 'choice'. If you are in the Drama specialisation, you will concentrate on synthesising the three areas of acting, voice and movement, in exercises designed to establish the basics of harnessing and focusing your expressive ability through self-awareness and examining the concept of 'choice'. If you are in the Technical Theatre specialisation you will explore stage lighting from the standpoint of aesthetics as well as the practical execution of the design concept.

Task Description

Music theatre specialisation

You will be required to complete a practical assessment in singing consisting of the following:

Technical exam (closed assessment within the exam period)

- Technical scales and exercises as set for Level 3, to be sung from memory.
- One vocalise by Giuseppe Concone's *Book of Vocalises, Opus 9*- choosing between numbers 13-25. The vocalise must be sung from memory, with piano accompaniment.

Performance exam (public performance at the end of the term)

- The program should demonstrate a choice of 4 works covering the different genres available throughout the history of 20th and 21st century music theatre with a total performance time of no longer than 15 minutes.
- The program should show a variety of styles and tempos and be sung entirely from memory.
- The program must include one song by Stephen Sondheim.
- The program must contain a 'combined discipline' piece. The combined discipline piece must be a song in which the student demonstrates the ability to use correct vocal technique whilst moving and to make effective change from speech to vocal qualities.
- The program is to be chosen in consultation with your Lecturer to ensure an appropriate level of difficulty is attempted.
- Program notes for the recital program must be submitted at the time of the vocal exam. They should be a minimum of 200 words for each piece of music that you are performing in your recital program. You do not need to do program notes for your Technical exam.

Drama specialisation

Performance exam (public or closed performance at the end of the term)

- You will be required to present a drama performance of material chosen in consultation with the drama lecturer.

Technical Theatre specialisation

- Technical Theatre Project 1 - Practical (20%)
 - subject area to be determined by the course coordinator and the technical theatre specialist staff
- Technical Theatre Project 1 - Written journal and research (10%)
